

THE PALMS MOTHER'S DAY FACEBOOK PROMOTION - TERMS AND CONDITIONS

1. This promotion is called The Palms Mother's Day Facebook Promotion. Participation in this promotion is deemed acceptance of the Terms and Conditions set out below.
2. Promotion commences at 6am (NZST) on Wednesday 6 May 2020 and will end at 9am Sunday 10 May 2020 ("Promotional Period").
3. There is a total of one prize consisting of one cake box (containing a mixture of 6 miniature cakes) and two drinks from the Coffee Essential menu from Coffee Culture The Palms.
4. To be eligible to go in the draw, customers must visit The Palms Facebook page and comment on the Mother's Day giveaway post.
5. There is a limit of one (1) entry per person.
6. The draw will take place on Sunday 10 May 2020 at 9:30am ("Draw"). The Promoter may draw additional reserve entries and record them in order in case an invalid entry or ineligible entrant is drawn. An entrant does not need to attend the Draw in order to win a prize.

8. The Promoters decision is final on all matters relating to this Promotion and no correspondence or discussion will be entered into.
