

THE PALMS TROLLS WORLD TOUR MOVIE PACKAGE PROMOTION - TERMS AND CONDITIONS

1. This promotion is called The Palms World Tour Movie Package Promotion. Participation in this promotion is deemed acceptance of the Terms and Conditions set out below.
2. Promotion commences at 9:30am (NZST) on Monday 6 July 2020 and will end at 3:30pm Friday 17 July 2020 ("Promotional Period").
3. There is a total of sixteen (16) Reading Cinema movie package prizes, each consisting of ten (10) movie passes to Trolls World Tour and ten (10) small popcorns. There will be eight (8) winners selected for the Trolls movie screening at 10am Sunday 12 July. And eight (8) winners selected for the Trolls movie screening at 10am Sunday 19 July.
4. To be eligible to go in the draw, customers must visit The Palms Shopping Centre between Monday 6 July to Friday 10 July, or Monday 13 July to Friday 17 July, between 9:30am and 3:30pm, play a free round of mini golf and submit their details at the registration desk.
5. There is a limit of one (1) entry per person, per day.
6. The draws will take place on Friday 10 and Friday 17 July 2020 at 4:00pm ("Draw"). The Promoter may draw additional reserve entries and record them in order in case an invalid entry or ineligible entrant is drawn. An entrant does not need to attend the Draw in order to win a prize.

8. The Promoters decision is final on all matters relating to this Promotion and no correspondence or discussion will be entered into.
