

THE PALMS LOVING LEVEL 1 \$10 FOOD VOUCHER PROMOTION - TERMS AND CONDITIONS

1. This promotion is called The Palms Loving Level 1 \$10 Food Voucher Promotion. Participation in this promotion is deemed acceptance of the Terms and Conditions set out below.
2. Promotion commences at 9am (NZST) on Thursday 25 June 2020 and will end at 9pm Friday 26 June 2020 (“Promotional Period”).
3. There is a total of two hundred (200) \$10 food vouchers available.
4. 100 vouchers will be handed out at random on Wednesday 24 June on Travis Road by The Edge Radio Station. 100 vouchers will be handed out at random on Thursday 25 June on Mairehau Road by Mai FM Radio Station.
5. To be eligible to redeem a prize, a customer must present the voucher at any participating food retailer at The Palms Shopping Centre during the Promotional Period. The voucher is valid for any food or drink purchase up to \$10.00. No change will be given.
