

THE PALMS LOVING LEVEL 1 \$1000 GIVEAWAY PROMOTION - TERMS AND CONDITIONS

1. This promotion is called The Palms Loving Level 1 \$1000 Giveaway Promotion. Participation in this promotion is deemed acceptance of the Terms and Conditions set out below.
2. Promotion commences at 9am (NZST) on Thursday 25 June 2020 and will end at 9pm Friday 26 June 2020 ("Promotional Period").
3. There is a total of two (2) prizes of \$1000 The Palms Gift Cards. There will be one winner selected from the Thursday entries and one winner selected from the Friday entries. Each prize consists of 2x \$500 The Palms Gift Cards.
4. To be eligible to go in the draw, customers must visit The Palms Shopping Centre and guess the total value of items within the vehicle either located by Kathmandu or Countdown. The entry form must have the entrants name, phone number, email address and answer and be deposited in the entry boxes located beside the vehicle.
