

## THE PALMS SELFIE WALL PROMOTION - TERMS AND CONDITIONS

1. This promotion is called The Palms Selfie Wall Promotion. Participation in this promotion is deemed acceptance of the Terms and Conditions set out below.
2. Promotion commences at 9am (NZST) on Wednesday 8 June 2020 and is on-going. ("Promotional Period").
3. There is no maximum number of prizes and prizes may consist of either The Palms Gift Card, free Coffee Vouchers, free Reading Cinema movie tickets or other retailer product.
4. To be eligible to go in the draw, customers must visit The Palms Shopping Centre, take a selfie in front of the Selfie Wall located behind Glassons and post it on Facebook using #LovingThePalms.
5. There is a limit of one (1) entry per person, per day.
6. Winners are drawn randomly ("Draw"). The Promoter may draw additional reserve entries and record them in order in case an invalid entry or ineligible entrant is drawn. An entrant does not need to attend the Draw in order to win a prize.
7. The winner will be notified via a Facebook message within two hours of the draw.
8. The Promoters decision is final on all matters relating to this Promotion and no correspondence or discussion will be entered into.
9. The winner must collect their prize from The Palms Shopping Centre Customer Service Kiosk located beside Cotton On. The winner must show proof of ID when collecting their prize.
